EROSION CONTROL CREW MEMBER

Location: Jobsite / DLC Office

Summary: Under the supervision of the Erosion Control Manager and Erosion Control Crew Leader perform duties in all aspects of Erosion Control, including Mulch and Hydroseeding operations, and the installation of BMP's for Air and Storm Water Pollution Control. Must be proficient in performing complex tasks of Erosion Control, Mulching, Hydroseeding, and BMP installation.

Essential Duties and Responsibilities include the following:

- Adhere to Company Safety programs
- Perform duties as directed by the Erosion Control Crew Leader
- Operate and maintain Express Blowers, Hydroseeders, and other equipment as needed to perform assigned work, including material handling, placing and maneuvering equipment hose, installation of materials, and site and equipment cleanup.
- Read and interpret plans and specifications as they pertain to erosion control projects. Ability to calculate material quantities, volumes, and areas.
- Ability to communicate and interact with DLC personnel, subcontractors, general contractors, and inspectors as required
- Ability to control traffic to include shoulder closures on freeways and surface streets
- Ability to maintain traffic control
- Adhere to safety standards while working on public roadways and equipment
- Always use proper lifting and carrying techniques
- Be familiar with reporting procedures in case of an accident, injury, or theft
- Be able to lift up to 75lb.

Miscellaneous:

- Assist the Crew Leader with other duties as assigned
- If issued a company cell phone, use for official business only
- Dispose and replace unsafe tools and equipment
